MINIMUM QUALIFICATIONS: Graduation from a four year college or university approved by the Council on Social Worker Education with a Master’s degree in Social Work plus experience (24 months or more) as a social worker in a mental health or medical field. **NECESSARY SPEICAL REQUIREMENTS:** Possession of or eligibility for licensure as a graduate social worker as issued by the Alabama Board of Social Work.

KIND OF WORK: Provide for the psychosocial needs of chronically, seriously mentally ill adults by coordinating placement of patients into the Department of Mental Health Community Residential Care Homes and other community resources in order to meet age specific needs as well as special needs relating to medical and physical problems and provide therapeutic placement opportunities for all patients referred by Treatment Teams. Coordinate screenings with mental health centers. Keep treatment teams informed; arrange for transportation and transmission of necessary information. Maintains contact with group homes and respond to emergency situations relating to patient’s adjustment into the community. Acts as liaison with MI Division and Central Office regarding placements of patients in residential care exchanging information on an ongoing basis.

REQUIRED KNOWLEDGE, SKILLS AND ABILITIES: Knowledge of community resources for the mentally ill. Ability to make clinical assessments. Knowledge of clinical and crisis interventions. Ability to communicate effectively both orally and in writing. Ability to keep accurate records and write reports. Ability to communicate effectively with all levels of staff, patients, and families in a professional and courteous manner at all times.

METHOD OF SELECTION: Applicants will be rated on the basis of an evaluation of their training, experience, and education, and should provide adequate work history identifying experiences related to the duties and minimum qualifications as above mentioned. All relevant information is subject to verification. **Drug test required. Security clearances will be conducted on prospective applicants being given serious consideration for employment and whose job requires direct contact with patients.**
