Public Health Emergency (PHE) Extension

The PHE has been extended until April 21, 2021, so the Appendix K would end no later than October 21, 2021. With the PHE extension ending in April, the enhanced FMAP will be available through June 30, 2021.

Funding Update

DDD has received the money back that was not spent from the original CARES funding. Providers were provided through January 22, 2021 to have all receipts for expenses incurred submitted. Providers should have submitted an invoice for expenses incurred through December 31st; a separate invoice for January expenses incurred through January 15, 2021; and also submitted separate invoices for Phase I and Phase II expenses.

The 19% increase in Residential Habilitation will continue in accordance with the updated extended PHE end date referenced above.

Vaccinations

ADMH-DDD participated in a weekly call facilitated by AARP to discuss the Alabama Department of Public Health's (ADPH) vaccination plan. Dr. Mary McIntyre, Chief Medical Officer, and Carolyn Bern, Director of Governmental Affairs and Community Relations, both were on the call to present information as of Friday, January 22nd. We will continue to participate in weekly calls and provide you the most updated information.

According ADPH, the COVID-19 vaccine is being administered in phases. Alabama is currently in Phase 1a. Healthcare workers in Phase 1a include, but are not limited to, emergency medical service personnel, nurses, nursing assistants, home healthcare personnel, physicians, technicians, therapists, phlebotomists, pharmacists, students and trainees, contractual staff not employed by the healthcare facility, medical supply delivery, mortuary services, and persons not directly

involved in patient care, but who could be exposed to infectious agents that can be transmitted in the healthcare setting (e.g., clerical, dietary, environmental services, laundry, security, engineering and facilities management, administrative, billing, and volunteer personnel). In essence those healthcare workers (provider DSPs and nurses) providing direct contact with vulnerable individuals are included in Phase 1a (This includes direct contact staff working in self-directed services). Direct contact does not include those providing virtual services.

As of January 18th, those identified in Phase 1a above and those in Phase 1b who are 75 years and older, and first responders, including firefighters and law enforcement **may receive the vaccine now.** Individuals served and staff as identified above may schedule an appointment with ADPH by calling the <u>COVID-19 Vaccine Scheduling Hotline</u> at 1-855-566-5333. If an appointment is not available at this time, your name will be taken, and you will be contacted when an appointment is available.

ADPH asked that you not call hospitals directly to schedule an appointment for the vaccine as they are being overwhelmed with calls.

After vaccination, it is recommended that individuals continue with the other prevention measures, such as washing your hands, wearing a mask, staying six feet apart, and limiting gatherings.

COVID-19 is a virus that has made many people very sick. Some people have died.




Now there is a vaccine. The vaccine is in a shot.

Getting the COVID-19 Vaccine Pt. 2




I may need to wait to make sure I am safe and healthy to go home.
