<u>Updates from the Office of Prevention</u> – Per Beverly Johnson

Introduced the new Epidemiologist, Brenae' Waters, that has previous Epidemiologist experience as the Alabama Department of Medicaid, along with the Alabama Department of Public Health

SOR 2.0 – No Cost Extension has been submitted.

SOR 3.0 – received a new five-year grant to sustain SOR services.

SPF Rx (2016) – recently closed out the grant.

SPF Rx 2.0 (2021) – received a new five-year grant to sustain SPF Rx services.

Overdose Data to Action cooperative agreement with AL Department of Public Health to provide services for the Center for Disease Control and Prevention grant.

PIPBHC – collaboration for services with AltaPointe Health

988 – crisis line for substance use, suicidal, mental health, emotional distress, etc. is operated by Wellstone Emergency Services (Region 1), Crisis Center Inc. (Region 2 & 3), and AltaPointe (Region 4). Carastar Health and SpectraCare Health Systems will be coming onboard this fiscal year.

2023 NPN Conference will be held in Birmingham, Alabama in August 2023.

Office of Prevention Strategic Plan will be submitted to the SPAB for review and approval.

Julia Simhai reported the Statewide Young Adult survey closed at end of September and was successful.

Sam Griggs nominated Nicole Shine, seconded by Gloria Howard as the new SPAB Secretary.

<u>New Business</u> – There was discussion regarding the workforce recruitment and retention funding.
