Request for Proposal Process (RFP)

The Alabama Department of Mental Health convened a diverse, multidisciplinary team of stakeholders, community leaders, providers, and state agency personnel.

- The Selection Committee was made up of Chair and Co-Chairs of the Alabama Opioid Overdose and Addiction Council, their designees, or the member was an individual invited at the Chair's recommendation.
- The Selection Committee was comprised of professionals with backgrounds in prevention, treatment, and recovery.
- No Selection Committee member submitted a proposal.
- No Selection Committee member was compensated for their time.

Award Process

ADMH received 52 submissions to the Request for Proposal. Of the proposal submitted 63% were funded. The following amounts were awarded to each category:

Award Process

RFPs were ranked in order of final score within each of the categories above. Awards were offered in order of final score - in amounts determined by proposed budgets - until funding in each category was no longer available. This process resulted in a diverse pool of awardees across the state.
