IV. DISCUSSION ITEMS:

Office of Prevention Updates: By Brandon Folks

FY 24 Block Grant has been awarded to a total of 15 contract providers.

Since August the Office of Prevention has been awarded two grants 988 State and Territory Improvement Grant and Project Zero Suicide. The 988 Improvement Grant is 3 years this grant will be used to improve the states response to 988 contacts by increasing the workforce, implementing additional technology, and improving support and service which is a collaborative initiative with Wellstone, JBS, Crisis Center Inc., AltaPointe, and SpectraCare. Project Zero Suicide is a 5-year grant that implements zero suicide intervention which is an initiative with vital.

AL crisis system of care 988 progress report 7/2022 – 8/2023 To date there have been a total of 52,714 total contacts. 35,000 calls, over 10,000 and 7,400 total chats. This is a 7000-contact increase from the last progress report.

Question for Brandon: Will the extra funding for SOR be added to the contracts and when? 10 agencies will receive \$11,393 via contract amendments that will be added to the operation line item.

Brandon Folks has recommended to the SPAB to revisit the Prevention Standards every five years for revisions or updates.

Shai Markis discussed creating a template for prevention professional salaries/ hourly wage.

April Knight suggested doing an educational session discussing what the requirements are to do prevention services.

April Knight suggested a sample pay scale for prevention professionals.

Brandon Folks suggested Seyram Selase present to the Substance Abuse Coordinating Subcommittee for the vote and approval.

The full group discussed the Opioid Settlement Dollars, and all updates from the Fentanyl Coalition zoom meeting. Nicole Shine provided details of the meeting in a quick overview. Mr. Retan was able to confirm for the coalition that an RFP will be posted within the next 60 to 90

days from the zoom meeting. Mr. Retan will provide details of the Opioid Settlement Hearing via email that's scheduled for November 16, 2023.
