**Human Rights Committee Training** 

The DD Division is proud to announce the continuation of training on the topic of Human Rights Committees. Trainings will be facilitated by Alabama Department of Mental Health staff members. One class will be offered in each region quarterly. We highly encourage members of Human Rights Committees, chairpersons, and others to attend this training. This training is also beneficial for agencies who participate in and/or facilitate Human Rights Committees at their organizations.

The goals of the one-day trainings are:

- 1. To understand the expanded focus on rights in the HCBS Settings Rule.
- 2. To understand the foundational principles of HRC operations.
- 3. To learn effective ways to apply these principles in individual rights protections and promotions.
- 4. To understand the committee's role in helping to prevent abuse, neglect, and exploitation.
- 5. To identify/create resource networks of assistance to help problem solve in the future.
- 6. To take back information to their agency to share with others.
