I. TIME OF MEETING CALLED TO ORDER With a quorum present, Mr. Atkins called the meeting to order at 11:12 AM.

The Chairperson called for a motion to adopt the agenda. Lisa Powell motioned to adopt the agenda. Seconded by Doris Hill, all ayes unanimous.

II. MINUTES OF THE LAST MEETING

The Chairperson called for the approval of the minutes from 2/16/24. Doris Hill motioned to approve the minutes from 2/16/24. Seconded by Lisa Powell, all ayes were unanimous.

III. OLD BUSINESS

1. Update on New Legislation

-The Department of Mental Health is to supply a support person/administrative assistant, dedicated phone line, financial assistance, legal assistance, and a dedicated office space.

-Ashley Nichols will keep the board updated with regards to the services to be provided and location (i.e., Developmental Disabilities or within the office of the Autism coordinator).

2. Update on licenses:

-Ken Atkins reviewed the number of licensees since the previous meeting. There were 52 new licensed Board Certified Behavior Analysts and 10 new licensed Board Certified Assistant Behavior Analysts. There were 2 licensed Behavior Analyst renewals. Doris Hill made a motion to approve the new licensees and renewal. Lisa Powell seconded, all ayes unanimous.

3. Update on New Board Members:

- The board members discuss potential psychologist board member candidates. Erich Grommet is a licensed BCBA and psychologist in Birmingham. The board members agree he will be a great asset for the board. Doris Hill makes a motion to elect Erich Grommet to the board, Lisa Powell seconds, all ayes unanimous.

4. Update on Fee Increase:

- The board will go through the department's legislative liaison to gain approval to increase the fees. Amendments may need to be made in order to do so. Mr. Nichols will determine the appropriate legal process and explore when the next legislative session will be. Lisa Powell motions to discuss the fee increase at the July meeting, Doris Hill seconds, all ayes unanimous.

IV. New Business

1. Discussion if the board wants to join the Alabama Association of Regulatory Boards (AARB) - The board discusses the pros and cons of joining the AARB. Lauren Elliott will look into what the association does as a member of the public.
2. Financial Report from treasurer- As of December 2023, the previous account balance was \$317, 744.00. There have been \$20, 045 in deposits since the last meeting and no expenses. Our projected account balance as of the end of March 2024 is \$337, 789.00. Lisa Powell motions to approve the financial report, Ken Atkins seconds, all ayes unanimous.
