Mission Statement: SCOPE 310's mandate by law is to serve individuals with developmental and intellectual disabilities who live in Colbert, Franklin and Lauderdale counties. Our practice is to be a place that recognizes the value of everyone. Our aim is to provide an environment where everyone, those served, paid staff, volunteers, families and friends, work together to bring out the best in each other.

Vision Statement: A dynamic, lifelong, service delivery system that empowers individuals with intellectual and/or developmental disabilities and their families to choose the services that enhance the quality of their lives, while maintaining the highest quality of services possible in a supportive, inclusive community.

Counties Served: Lauderdale, Colbert, Franklin for planning purposes. In addition, we provide support coordination in Cullman, Winston, Marion, Fayette, Walker and Lamar counties.

Population Served: Early Intervention services and DD services through the Alabama Department of Mental Health DD Division.

Supports and Services Currently Provided: Early Intervention, Single Point of Entry, Support Coordination, Residential Services, Day Habilitation Services and Personal Care Services.

Description of Planning Process/Cycle: Feedback and information for planning was gathered through both electronic (Survey Monkey) and traditional means (postal mail) from stakeholders beginning the last quarter of the fiscal year 2025. In addition, ongoing feedback is consistently gathered from people served, their families and other stakeholders.

Methods and Results of Needs Assessment: The Board of Directors reviewed the input and validated the results for submission to the Department of Mental Health.

Stakeholders and Their Involvement: Input was gathered as addressed above formally.

Community Providers and Their Involvement: Formally this is done through SCOPE employees' involvement in numerous committees and councils that meet throughout the year such as: FACT

for all counties; DHR QA councils, etc. In addition, community stakeholders were included in both the Survey Monkey notifications and the regular mail surveys.

Areas of Greatest Identified Unmet Need: Residential services, traditional day services and Navigating the System Training.
